NOTE: A properly executed history and physical is valid for the entire length of stay. Any changes to the patient 's condition would be documented in the daily progress notes. A new H & P or update to the H & P is not required when the patient remains continuously hospitalized. If the patient has been discharged, then readmitted, there must be a valid history and physical (no greater than 30 days) and updated within 24 hours after readmission/registration but prior to a surgical procedure ...

Interpretive Guidelines § 416.52(a)(1) The purpose of a comprehensive medical history and physical assessment (H&P) is to determine whether there is anything in the patient's overall condition that would affect the planned surgery, such as a medication allergy, or a new or existing co-morbid condition that requires additional

#### CMS Manual System

(i) A medical history and physical examination be com-pleted and documented for each patient no more than 30 days before or 24 hours after admission or registration, but prior to surgery or a procedure requiring anesthesia services. The medi-cal history and physical examination must be completed and documented

# The 24-Hour History and Physical Examination Regulation ...

1995 Documentation Guidelines: A brief HPI describes one to three elements from the list, such as location, quality, and severity. An extended HPI consists of four or more elements. 1997 Documentation Guidelines: Again, a brief HPI includes one to three elements, but the 1995 and 1997 Documentation Guidelines differ for extended HPI. The 1997 Documentation Guidelines state an extended HPI is at least four elements OR the status of at least three chronic or inactive conditions.

### Detailed E/M Coding History and Components - AAPC

The Centers for Medicare & Medicaid Services (CMS) no longer requires a history and physical (H&P) prior to surgery. Each facility will determine for themselves the timing and extent of the H&P required for outpatient procedures. The Academy has provided guidelines when physicians choose to perform the H&P themselves.

### Complying With Medical Record Documentation Requirements

CMS' Conditions of Participation state that the requirements for completing and documenting patient histories and physical examinations are contained in the medical staff bylaws (CFR § 482.22 [c][5][i-ii]). The Joint Commission also addresses these requirements in the Medical Staff (MS.01.01.01, EP 20, and MS.03.01.01) and Provision of Care (PC.01.02.03, EPs 4 and 5) chapters of the hospital standards.

History and Physical: In April TJC posted 4 new frequently asked questions or standards interpretations, at least 3 of which are very important and frequently asked.
